Monthly County Relief Report

Vouchers issued in 2025 have surpass the issued amount in 2024, except for Food vouchers.

Non-Financial Assistance is completed by front desk staff, which includes assisting with paperwork, making appointments, requesting summary of benefits letters, assisting with requesting dd 214, and other tasks.

VETPRO data for August 2025: 2nd highest month for Compensation Awards payments. July 2025 was the 1st highest. Total activity for 2106. Damion and Brian have been filing claims and are scheduled about 2 weeks out. Currently 6 VSOs available to assist veterans.

Old Business: Nominations for Vice President and Chaplain.

New Business:

Guest Speaker: Shawn Slavish from ILARNG (Illinois active and reserve National Guard)- His position is the Military and family Readiness Specialist. He assists active duty with different family events, support groups, send personnel over to VAC to get assistance as needed, outreach, attend meetings to share the word about the different events within the community, and job events for veterans to find jobs. As a NG representative, he is one of 14 personnel throughout Illinois, that assist throughout the state in multiple areas. There are approximately 100 NG members from IL servicing thought-out the world that have been activated.

Kevin Kilkenny was nominated for Vice President: 1st nomination Kevin Kastelic; 2nd nomination Roger Oliver.

Emergency Fund donations: Veterans donate to fund, that assists with emergency situations for veterans.

Upcoming by-law reviews: Brad and Parris are updating the current by-laws. Some protocols are outdated and need to better fit us as an organization. By laws will be ready for review by the commission in the near future.

Brad and Parris will be attending the RI County Board Meeting in October. Objectives are to keep board inform of the things VAC does, share what is needed and how things impact the veterans and develop relationship with board. At February 202 meeting provide annual report that shows how many veterans were assisted for 2025 and future expansion for assistance in the future.

VET center and VAC MOU was signed last week. Plans to start executing in November2025. Jason and Cory will be there twice a month. The center provides mental health counseling, assist veterans with claims for certain claims, are part of VA Health Care, assist with stand downs, and services are free.

Outreach changes within the VA Health Center, VET Center, and Vetnet, days being decided.

Brad and Parris will be attending Bridging the Gap on September 26, 2025. Parris will be presenting a presentation at the American Legion. Brad and Parris are attending IDES Success Fair on November 13, 2025.

Anonymous Grateful God Star Banquet summary of accomplishments will be this coming weekend, Cory will attend.

Other Business:

Parris: National Conference being attend yearly. NETVSO has apparel available for VSO.

As of 7/2025, there were approximately 180,000 claims back logged and is the lowest ever. Some claims have been denied without correct process. Process time has decreased from 130 days to 94 days from a few months ago. Medical records are the #1 reason connected to claims. Military Orders are another way to locate areas veterans served.
