

## 1. AUTHORIZATION REQUIREMENTS.

Application is hereby made for a Floodplain Development Authorization (hereafter called authorization) as required under Rock Island County Code of Ordinances, § 154.610 - § 154.621, for development as defined in said ordinance. The applicant understands and agrees that:

- a. If the proposed development is located wholly or partly within an identified Floodway of the Mississippi or Rock Rivers, authorization will be withheld until a permit is issued by the Illinois Department of Natural Resources/Office of Water Resources. Applicant understands that the issuance of a Development Authorization only authorizes the issuance of permits or approvals, e.g. building permit, subdivision plat approval, as required by the various county departments. Applicant understands that the issuance of a Development Authorization implies no approval of any plans except as pertaining to the regulations of said § 154.610 - § 154.621;
- b. The authorization applied for, if granted, is issued on the representations made herein;
- c. That any authorization issued may be revoked because of any breach of representation;
- d. That once an authorization is revoked, all work shall cease until the authorization is reissued or a new authorization is issued;
- e. Any authorization issued on this application will not grant any right of privilege to erect any structure or use any premises described for any purposes or in any manner prohibited by the ordinances, codes, or regulations of the County;
- f. The building or development site shall not be used or occupied unless an occupancy certificate has been issued by the Building Official;
- g. The applicant hereby gives consent to the designated officials of the Rock Island County, IL, to make reasonable inspections to enforce the provisions of said section without first obtaining a search warrant; and
- h. If issued, the authorization will expire if no work is commenced within six (6) months of issuance.
